INTERGOVERNMENTAL VACATION ORDINANCE

WHEREAS, the City of Chicago is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 6321-6359 S. Peoria Street and 6320-6358 S. Green Street are owned by the City of Chicago; and

WHEREAS, the Department of Planning and Development ("Department") proposes to assemble properties including the portion of the street and alleys to be vacated; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of public use and the public interest to be subserved is such as to warrant the vacation of part of the public street and alleys described in the following ordinance; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1.

PEORIA DRIVE PER CITY OF CHICAGO OPENING DOCUMENT RECORDED MAY 14, 1969 AS DOCUMENT 20841282, LYING WITHIN LOT 29 AND PART OF LOTS 27, 28, AND 30, ALSO THAT PART OF A NORTH-SOUTH 16 FOOT WIDE PUBLIC ALLEY LYING EAST OF LOTS 12 THROUGH 28, AND WEST OF LOTS 29 THROUGH 45, IN THE LUCY M. 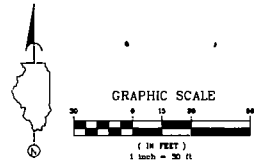
SECTION 2. The vacations herein provided for are made upon the express condition that within 180 days after the passage of this ordinance, the Department or its assigns shall deposit in the City Treasury of the City of Chicago, a sum sufficient to defray the costs of removing paving, diverter and curb returns, and constructing parkway, sidewalk, cul de sac, etcetera, in accordance with the approved plan and the most current version of the Chicago Department of Transportation's Regulations for Opening, Repair and Construction in the Public Way and its appendices,

SECTION 3. The vacations herein provided for are made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Department shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the associated full sized plat as approved by the Department of Transportation's Acting Superintendent of Maps and Plats.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and approval. The vacations shall take effect and be in force from and after recording of this ordinance and the associated plat.
