
to those of a RM5 Residential Multi-Unit District and a corresponding uses district is



In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about **November 29, 2018**, I, the undersigned, intend to file an application for a change in zoning from an RT-4 Residential Two-Flat, Townhouse, and Multi-Unit District to an RM-5 Residential Multi-Unit District, on behalf of the Applicant/Owner – 831 North Damen Homeowners Association, for the property located at 831 North Damen Avenue, Chicago, Illinois.

The existing three-and-a-half-story (with basement) residential building, which is situated along the north property line and measures more than 38 feet-0 inches in height, presently contains six (6) dwelling units. The existing building – therefore, is *non-conforming*, under the current Zoning Ordinance. The Applicant is seeking a Zoning Map Amendment, in order to permit the renovation and expansion of the existing *non-conforming* building and the six (6) dwelling units located therein. Part of the proposed renovation plan calls for the buildout of the 'attic' (dormer), above the third-floor, in order to provide additional habitable space for the residents of the two (2) dwelling units, located on the third-floor of the existing building. No additional dwelling units are intended or contemplated. As such, the building will continue to contain a total of six (6) dwelling units, upon completion of the proposed renovation work. There is – and will remain – onsite surface parking for three (3) vehicles, located at the rear of the building. The proposed renovation work will be completed in masonry and stone, to match the design of the existing building. Upon completion of the proposed renovation work, the building will measure 45 feet- 0 inches in height. The proposed Zoning Change is also required to cure the current *non-conforming* conditions, at the property, and to bring the existing building into compliance, under the Zoning Ordinance.
