#19884-TI INTRO DATE DEC 12, 2018

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 5-K in the area bounded by

West Armitage Avenue; North Kenneth Avenue; a public alley next south of and parallel to west Armitage Avenue; and a line 49.5 feet west of a parallel to North Kenneth Avenue

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.






