BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit District symbols and indicators as shown on Map No. 5-M in the area bounded by


North McVicker Avenue; a line 73.30 feet south of and parallel to West Wabansia Avenue; the public alley next west of and parallel to North McVicker Avenue; and a line 103.30 feet south of and parallel to West Wabansia Avenue.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about December 5, 2018, the undersigned will file an application for a change in zoning from RS-3 Residential Single-Unit District to RT-4 Residential Two-Flat, Townhouse and Multi-Unit District on behalf of Eddy Gonzalez for the property located at 1648 N. 
