BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single-Unit (Detached House) District symbols and indications as shown on Map Number 14-F in the area bounded by:

A line 22.33 feet east of and parallel to South Union Avenue; West 59th Street; a line 47.33 feet east of and parallel to South Union Avenue; and a line 100 feet south of and parallel to West 59th Street;

to those of B1-1, Community Shopping District.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and due publication.



In accordance with the requirements of Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about November 21, 2018, **THE PERDUE FAMILY TRUST DATED 7/31/18** (the "Applicant") will file an application for rezoning (the "Application") for the property commonly known as 655 W. 59th Street, Chicago, Illinois (the "Property").

The Application will request City of Chicago approval to rezone the Property from RS-3, Residential Single-Unit (Detached House) District to B1-1, Community Shopping District for the purpose of using the existing one-story building on the Property for Applicant's office space (real estate business), as well as office space rental, artist work space and a community garden ("proposed uses"). The building on the Property was formerly a church and is currently vacant. The proposed uses for the Property will help enhance the fabric and aesthetics of the neighborhood.


