#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **B3-2 Community Shopping District** symbols and indications as shown on Map No. 7-J in the area bounded by

West Oakdale Avenue; North Central Park Avenue; a line 58.45 feet south of and parallel to West Oakdale Avenue; and the alley next west of and parallel to North Central Park Avenue

to those of a C1-3 Neighborhood Commercial District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.





In accordance with Section 17-13-0107 of the Chicago Zoning Ordinance, please be informed that on or about January 16, 2018, the undersigned will file an application for a change in zoning from a B3-2 Community Shopping District to a C1-3 Neighborhood Commercial District on behalf of 2922-24 North Central Park, LLC (the "Applicant") for the property located at 2922-24 N. Central Park Ave. / 3609 W. Oakdale Ave., Chicago, IL 60618 (the "Subject Property").

The Applicant is seeking a zoning amendment for the Subject Property to erect a 1 story addition on the south elevation (10'-2" in height, 930 sq. feet in area), with alterations to the existing 1st floor space to include the de-conversion of the 1st floor rear dwelling unit and expansion of the existing tavern into the entire 1st floor space, and to expand the tavern into an outdoor patio space on the ground level in the adjacent lot to the south (1,821 sq. feet in area). The building located at 2922-24 N. Central Park Ave. / 3609 W. Oakdale Ave., Chicago, IL 60618 is 7,374 square feet, consisting of 3 stories & a basement space.
