ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 4-H in the area bounded by

West 21st Place; South Damen Avenue; the public alley next south of and parallel to West 21st Place; a line 25.00 feet west of and parallel to South Damen Street

to those of B1-3 Neighborhood Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

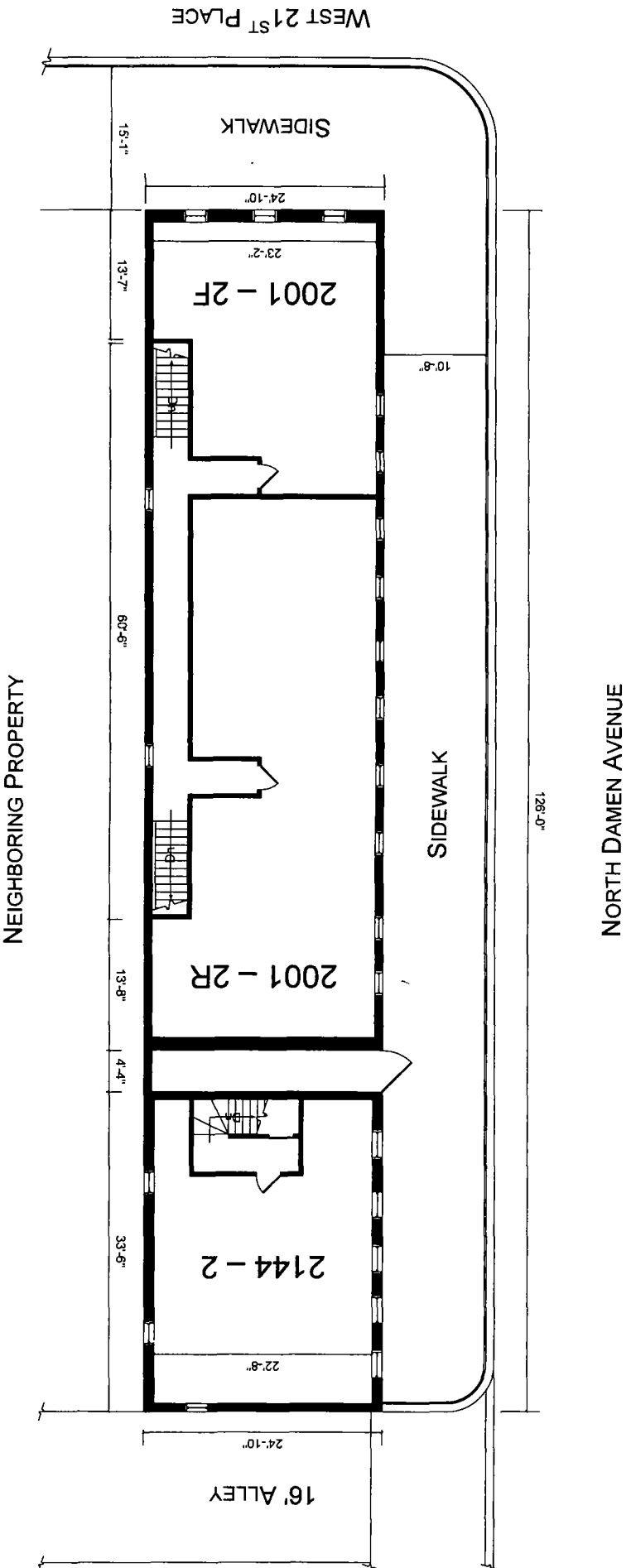

2001 WEST 21ST PLACE - 2ND FLOOR SITE PLAN

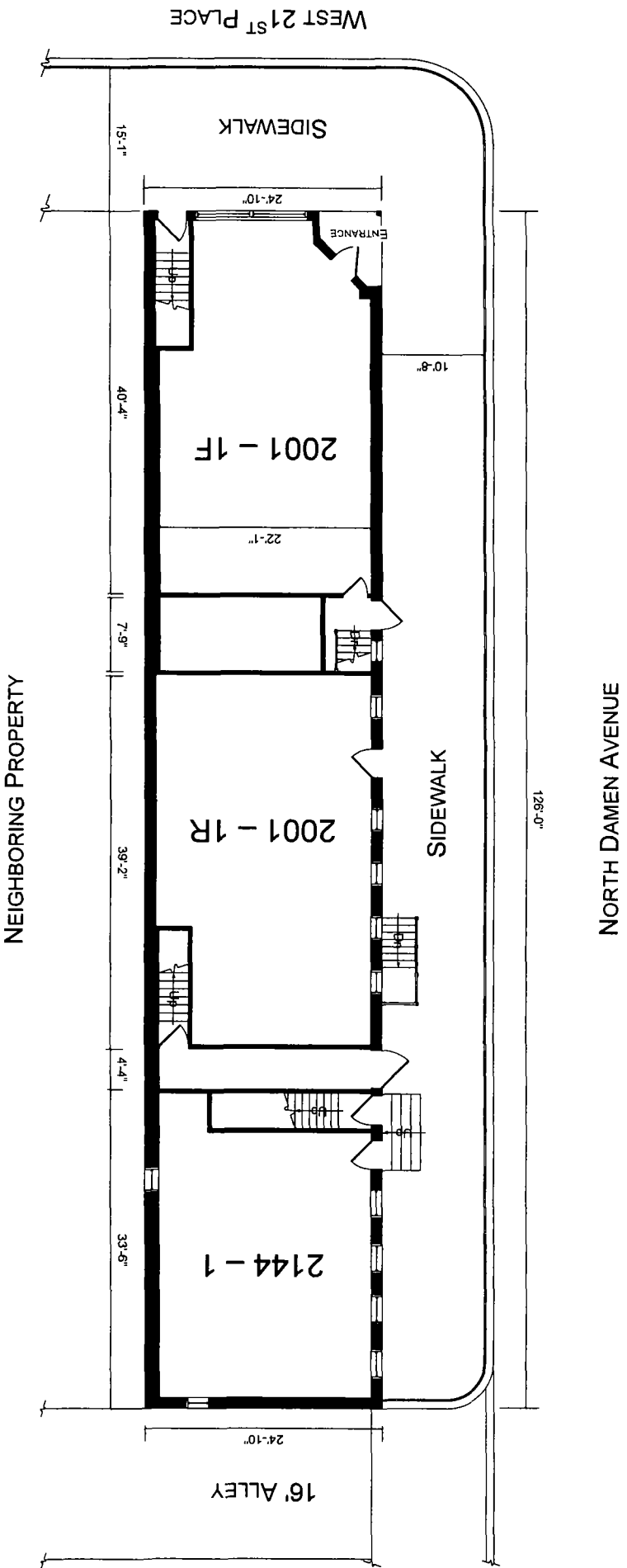

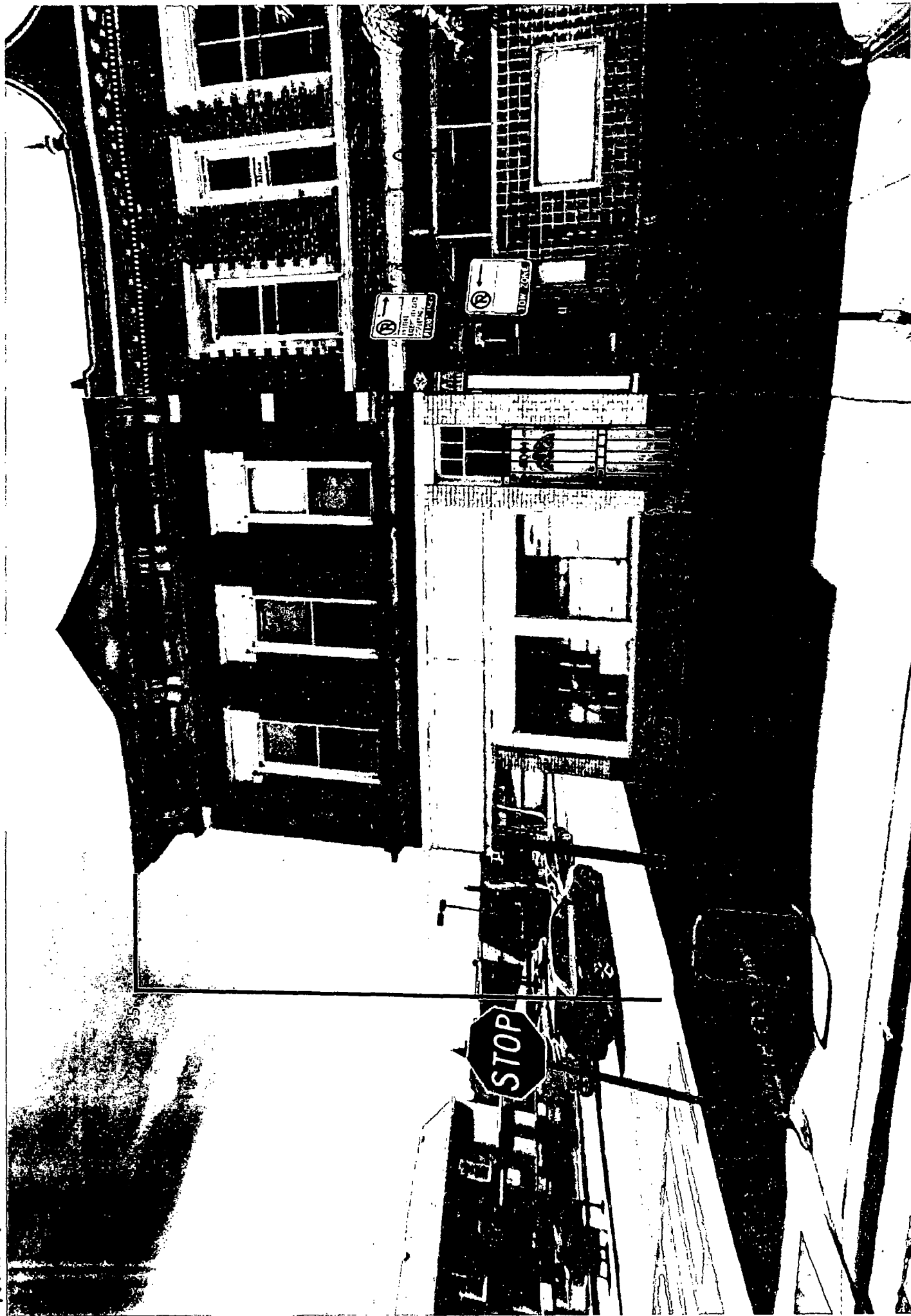


2001 WEST 21ST PLACE – 1ST FLOOR SITE PLAN

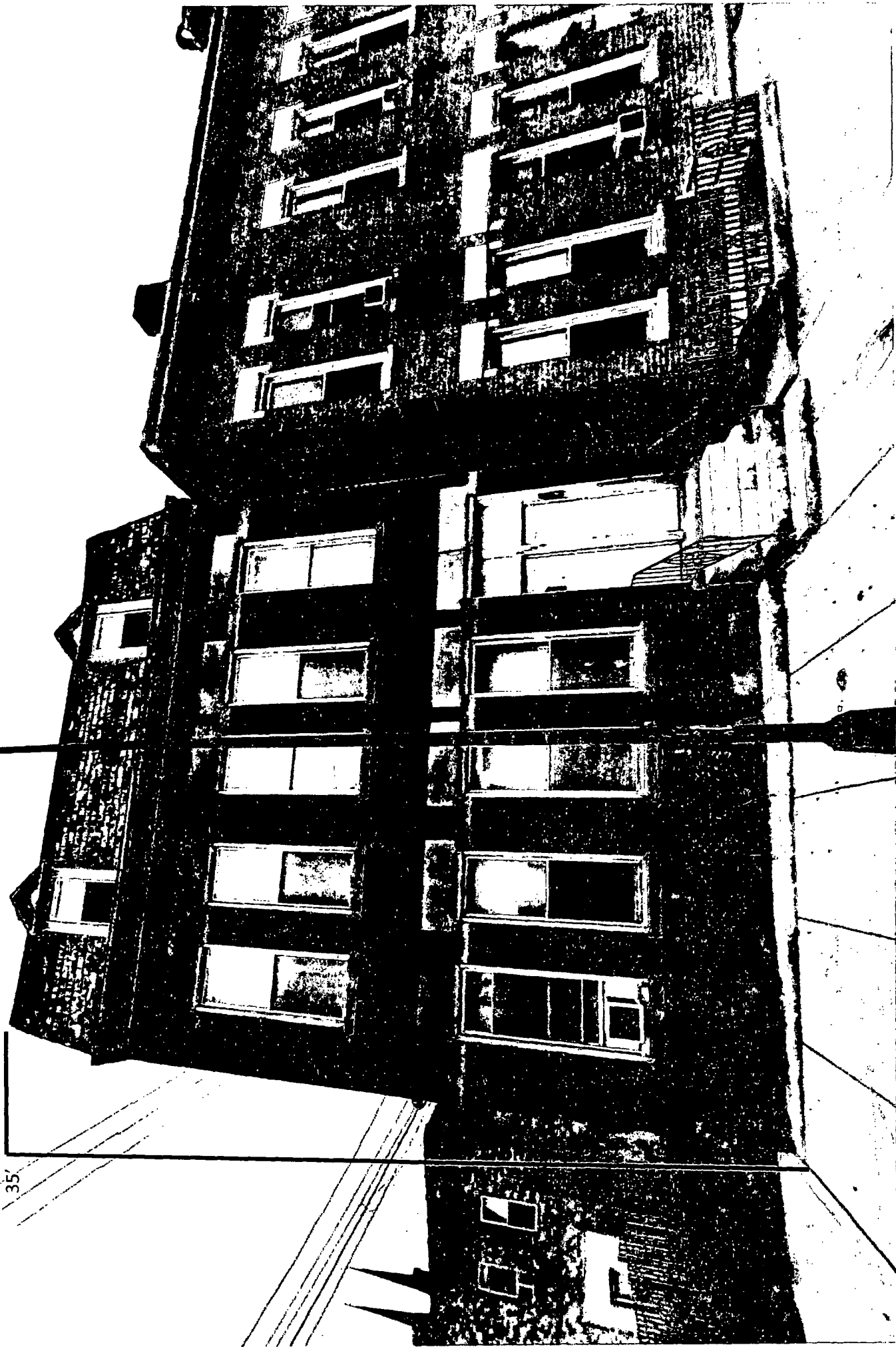


NORTH ELEVATION



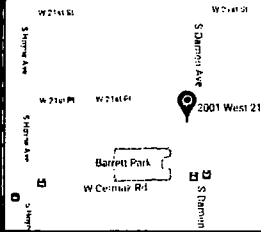

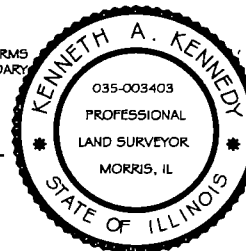
