## **ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.3-H in the area bounded by

a line 71.40 feet southeast of and parallel to North Wolcott Avenue;  
North Wicker Park Avenue; a line 95.40 feet southeast of and parallel  
to North Wolcott Avenue; and the alley next southwest of and parallel  
to North Wicker Park Avenue,

to those of a RM4.5 Residential Multi-Unit District is hereby established in the area  
above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage  
and due publication.
