
SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 5-J in the area bounded by:

West Cortland Street; North Central Park Avenue; the public alley next south of West Cortland Street; and a line 121 feet west of North Central Park Avenue

to those of a RM5 Residential Multi-Unit District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 5, 2019, the undersigned will file an application for a change in zoning from a RT-4, Residential Two-Flat, Townhouse and Multi-Unit District to a RM-5, Residential Multi-Unit District on behalf of Guardian Bucktown, LLC (the "Applicant") for the property located at 3601-11 West Cortland Street / 1844-56 North Central Park Avenue, Chicago, Illinois, 60647.
