ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the C3-5 Commercial Manufacturing and Employment District symbols and indications as shown on Map No.3-G in the area bounded by

a line 43 feet south of and parallel to West Weed Street; North Halsted Street; a line 108 feet south of and parallel to West Weed Street; and the alley next west of and parallel to North Halsted Street,

to those of a B3-5 Community Shopping District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

1530-1534 North Halsted Street, Chicago, Illinois

Proposed Zoning: B3-5 Community Shopping District

Lot Area: 8,190 square feet

Proposed Land Use: The Applicant is seeking a zoning change in order to permit the rehabilitation and expansion of the existing one-story retail/commercial building. Part of the rehabilitation plan calls for the erection of a new three-story vertical addition – above the existing one-story building. The 1st Floor of the newly expanded building, which presently contains two retail/commercial ‘storefronts’ - that can be combined into a single unit, will remain unchanged. The new proposed three-story addition will contain a total of twelve (12) dwelling (residential) units – four (4) units, each, on the 2nd thru 4th Floors. There will be a roof deck, located above the new 4th Floor, which will be for the exclusive use and enjoyment of the residential tenants of the building. The subject property is located within 1,320 linear feet of the entrance to the North Avenue CTA (‘Red Line’) Station, and – therefore, the redevelopment plan qualifies for reduced vehicular parking, pursuant to the Transit Oriented Development (TOD) Ordinance. As such, there will be surface parking for a total of six (6) vehicles, located onsite – at the rear of the building. The existing building, with the proposed three-story addition, will be masonry, glass and steel in construction and will measure 61 feet-4 inches in height.

- (A) The Project’s Floor Area Ratio: 23,433 square feet (2.86 FAR)
- (B) The Project’s Density (Lot Area Per Dwelling Unit): 12 dwelling units (682.5 square feet)
- (C) The amount of off-street parking: 6 vehicular parking spaces

 - a. Front Setback: 1 feet-0 inches

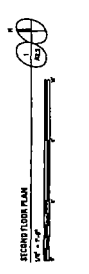

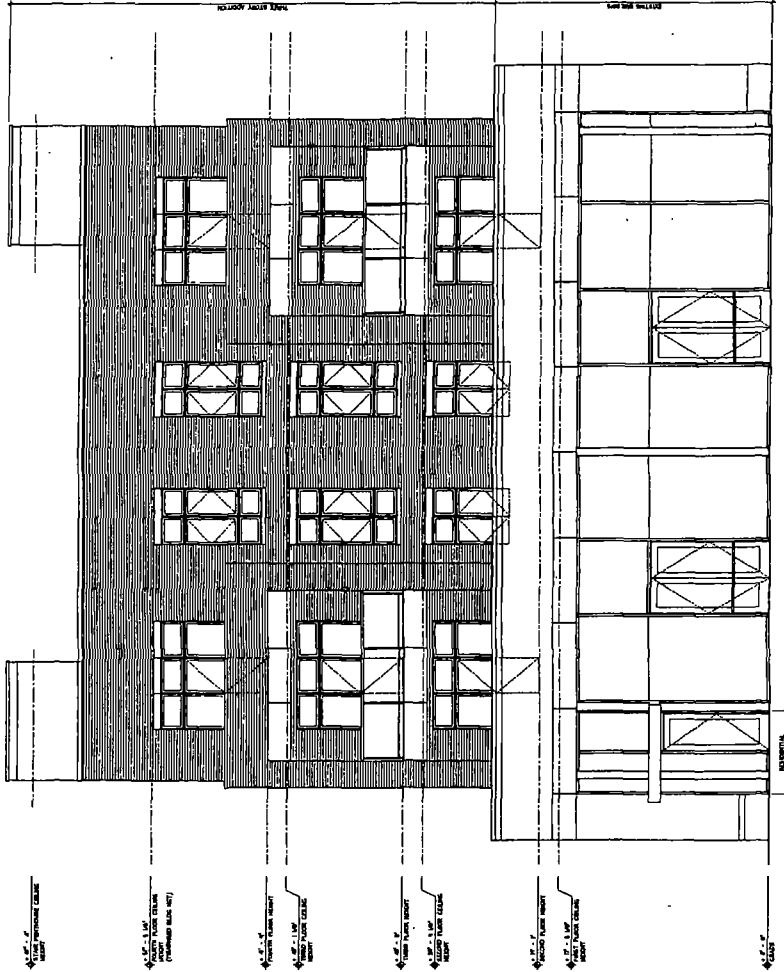

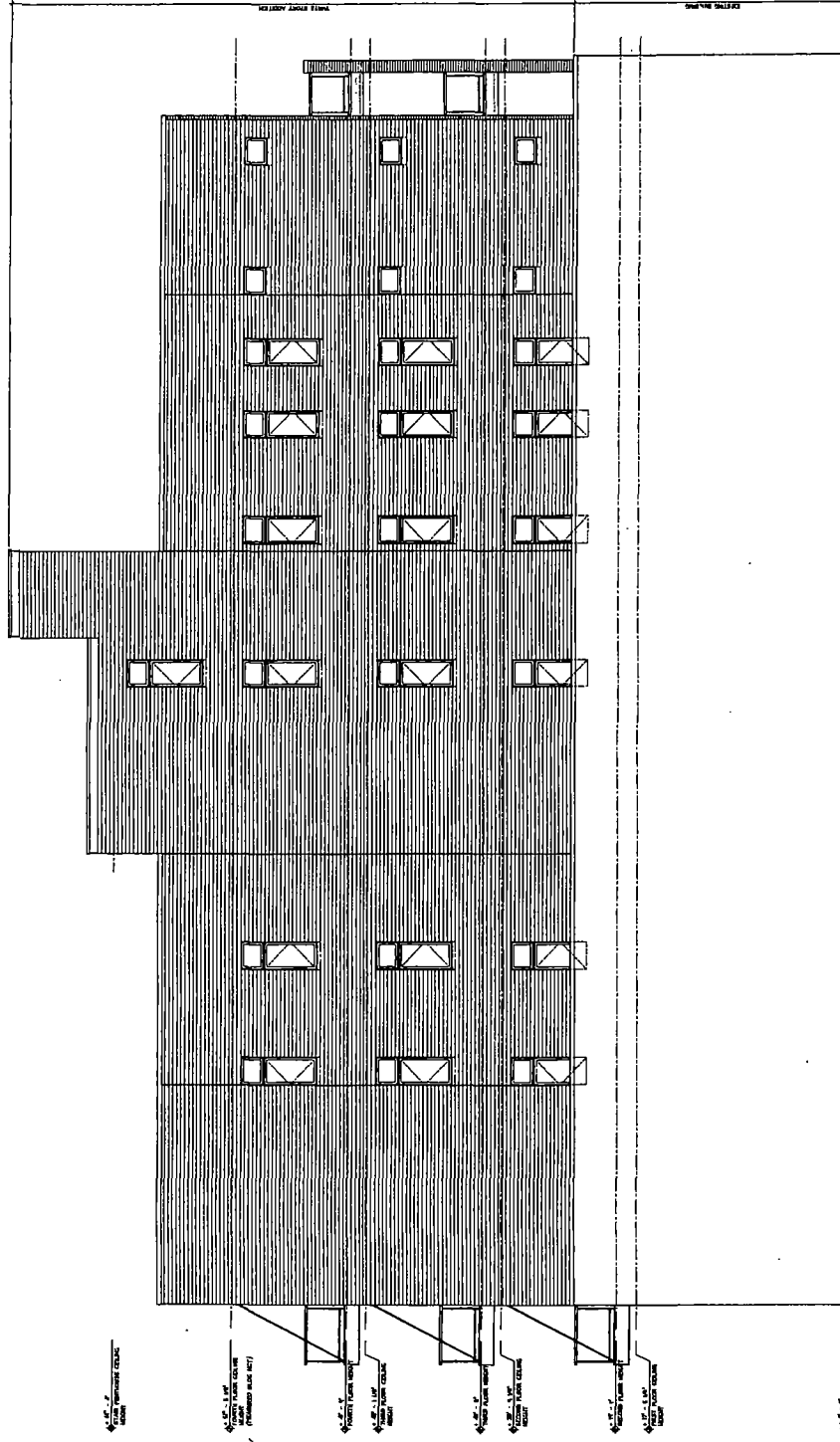

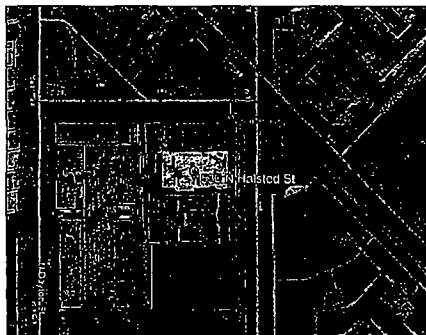
