BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2, Community Shopping District symbols and indications as shown on Map No. 7-G in an area bound by

A line 100.00 feet west of and parallel to North Kenmore Avenue; West Belmont Avenue; a line 50 feet west of and parallel to North Kenmore Avenue; the public alley next south of and parallel to West Belmont Avenue;

to those of a B3-3, Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.
