**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 9-J**

**in the area bounded by:**

**A line 224.18 feet South of and parallel to West Roscoe Street; North Ridgeway Avenue; a line 261.68 feet South of and parallel to West Roscoe Street; the public alley next West of and parallel to North Ridgeway Avenue.**

**To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**

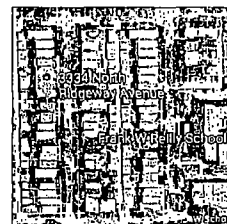

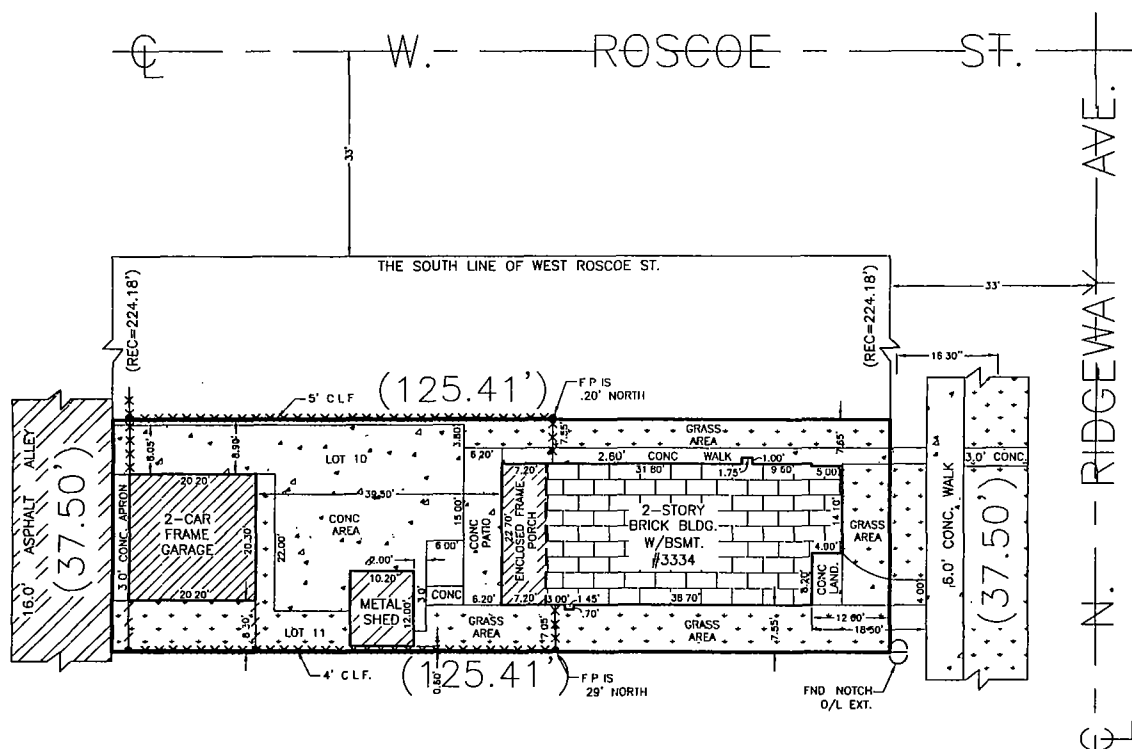
