a line 213.9 feet north of and parallel to West 43rd Street; the alley
next east of and parallel to South Halsted Street; West 43rd Street; and South Halsted Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.
