SECTION 1. Pursuant to Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt *Islamic Community Center of Chicagoland, Inc.* from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for *4846-4856 N. Elston.*
