ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B2-2 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 3-H in the area bounded by

North Milwaukee Avenue; a line 100 feet southeast of the intersection of North Damen Avenue and North Milwaukee Avenue as measured along the southwesterly right-of-way line of North Milwaukee Avenue and perpendicular thereto; the east right-of-way line of North Damen Avenue; and a line 50 feet southeast of the intersection of North Damen Avenue and North Milwaukee Avenue as measured along the southwesterly right-of-way line of North Milwaukee Avenue and perpendicular thereto,

to those of a C1-3 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The Applicant is seeking a zoning change in order to permit the location and establishment of a retail facility, with incidental medium event venue space, within the 1st Floor of the existing four-story (with basement) mixeduse (commercial-residential) building, at the subject site. Part of the rehabilitation plan calls for the interior buildout of the existing grade-level storefront, to accommodate for a new retail tenant, which plan also includes the erection of a small café-bar, within the storefront, which will operate in conjunction with the retail facility. The remainder of the existing four-story building will remain unchanged, so that there will continue to be eleven (11) dwelling units located on and between the 2nd thru 4th Floors. 





First Floor Plan









Fourth Floor Plan Second Floor Area: 4,575 sf


