ABERDEEN OWNER, LLC

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to ABERDEEN OWNER, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Cornice(s) projecting over the public right-of-way adjacent to its premises known as 740 N. Aberdeen St..

Said Cornice(s) at N. OGEN AVENUE measure(s):

One (1) at one hundred eight point eight five (108.85) feet in length, and one point zero eight (1.08) foot in width for a total of one hundred seventeen point five six (117.56) square feet.

One (1) at forty-two point one (42.1) feet in length, and one point two three (1.23) foot in width for a total of fifty-one point seven eight (51.78) square feet.

Said Cornice(s) at N. ABERDEEN STREET measure(s):

One (1) at eighty point one two (80.12) feet in length, and one point zero eight (1.08) foot in width. for a total of eighty-six point five three (86.53) square feet.

One (1) at thirty-seven point one two (37.12) feet in length, and one point two three (1.23) foot in width for a total of forty-five point six six (45.66) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1139667 herein granted the sum of one thousand six hundred (\$1,600.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
