To Whom It May Concern,

Per section 17-13-0307 of the Chicago Zoning ordinance, a Valid Written Protest may be filed if signed and acknowledged by *"property owners of land immediately touching, or immediately or immediately across the street from at least 20% of the perimeter of the land to be rezoned"*.

We note that there are two multiunit residential properties immediately touching the land to be rezoned (850 W Adams and 111 S Peoria), and one multiunit residential property immediately across the street (123 S Green). We also note that, between these three buildings there are 328 PINs (excluding parking spaces). **The signatures below from protesting property owners below represent over 20% of those PINs.**
