**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 1-G in the area bounded by

West Superior Street; North Bishop Street; The public alley next south and parallel to West Superior Street; A line 50 feet west of and parallel to North Bishop Street

to those of a B2-3 Neighborhood Mixed-Use District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

## TYPE 1 ZONING AMENDMENT

### 1447 WEST SUPERIOR STREET

#### B2-3 Neighborhood Mixed-Use District

The applicant is requesting a zoning amendment from a RS-3 Residential Single-Unit (Detached House) District to a B2-3 Neighborhood Mixed-Use District for the renovation of the existing 2 story building that has 34-bed convent and office space. After the renovation, the building will have a total of 16 residential dwelling units and 21 bicycle parking spaces. \*6 parking spaces will be provided off site. The building height is existing at 31'2". No commercial space will be provided.

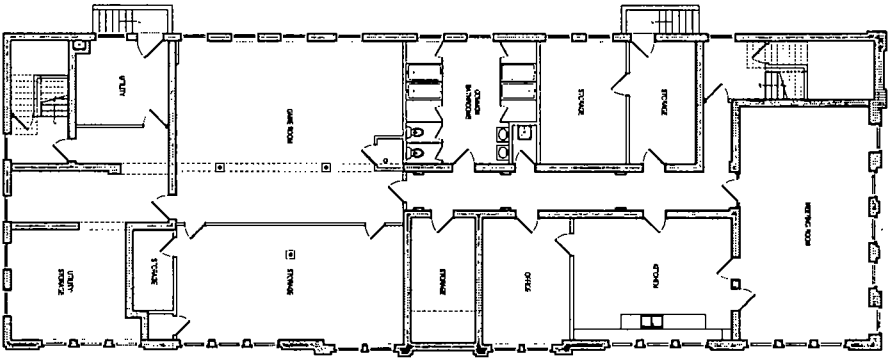

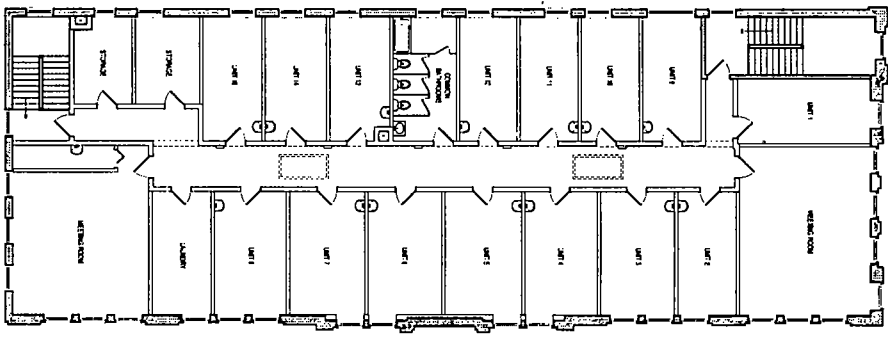
