
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single Unit (Detached House) District symbols and indications as shown on Map No. 7-J in an area bound by

The public alley next north of and parallel to West Diversey Avenue; a line 52 feet east of and parallel to North Avers Avenue; West Diversey Avenue; And North Avers Avenue

to those of a C2-1, Motor Vehicle-Related Commercial District. SECTION 2. This ordinance takes effect after its passage and due publication.


