ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single–Unit (Detached House) District symbols as shown on Map No. 7-M in the area bounded by:

West Diversey Avenue; a line 50 feet west of and parallel to North Mobile Avenue; a public alley next south of and parallel to West Diversey Avenue; a line 104.86 feet west of and parallel to North Mobile Avenue.

To those of a C1-1, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and due publication.




