#20086 INTRODATE July 24,2019

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the current Business Planned Development 1047 symbols and indications as shown on Map Number 9-G in the area bounded by:

a line 141.15 feet north of and parallel to West Addison Street; North Southport Avenue; a line 91.15 feet north of and parallel to West Addison Street; and the public alley next west of and parallel to North Southport Avenue

To those of a B3-2 Community Shopping District.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about July 17, 2019 the undersigned will file an application for a change in zoning from Planned Development 1047 to B3-2 Community Shopping district for the property located at 3608-3610 North Southport Avenue.

The applicant seeks an amendment to the zoning ordinance to correct an error in the zoning map. The subject property was erroneously including in PD 1047. PD 1047 encompasses the Jewel store located at 3630 N. Southport.
