BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current B2-2 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 4-G in the area bounded by:

West 18th Street; the public alley next west of and parallel to South Peoria Street; the public alley next south of and parallel to West 18th Street; and a line 74.75 feet west of the alley next west of and parallel to South Peoria Street

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
