**ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-3, Light Industry District symbols as shown on Map No. 76-B for the property located in the area generally bounded by:

Courtland Street; North Clybourn Avenue; Clifton Avenue; a line 46.85 feet southwest of and parallel to North Clybourn Avenue; a line 10.39 feet extended southwest and parallel to North Clifton Avenue; a line 7.69 feet extended northwest and parallel to Clybourn Avenue; a line 0.92 feet extended northeast and parallel to North Clifton Avenue; a line 55.69 feet extended northwest and parallel to North Clybourn Avenue; a line 110 feet parallel to North Clifton Avenue; and North Marcey Street,

to the designation of C2-3, Motor Vehicle-Related Commercial District.

**SECTION 2.** This ordinance takes effect after its passage.

## **TYPE 1 NARRATIVE 1960-1980 NORTH CLYBOURN AVENUE**


The subject property consists of three contiguous parcels located on North Clybourn Street (the “Property”). There are three buildings, including a surface parking lot between the 1970 North Clybourn and 1980 North Clybourn buildings. The total site area is 33,705.12 square feet (0.77 acres). The Property is currently zoned M2-3 and is located in the North Branch Industrial Corridor. The proposed zoning classification is C2-3, Motor Vehicle-Related Commercial District.

Prior to 1988, the Property was zoned M2-3, and in 1988, the Property was included in the Clybourn Corridor PMD (PMD 1), Subarea B (Buffer). In 2017, the City modernized the North Branch Industrial Corridor by abolishing PMD 1, and rezoned the Property back to its historical classification of M2-3. In addition to a Type 1 Rezoning, Section 17-13-0402 of the Chicago Zoning Ordinance requires a public hearing to be held by the Chicago Plan Commission on applications to rezone land within an industrial corridor from an “M” zoning district classification to any other zoning district classification.

By rezoning the Property from PMD 1 to M2-3, the City of Chicago created non-conforming uses of the retail uses at this location. Although “Retail Sales, General” is a permitted use in the M2 District, the corresponding use standard limits retail sales to accessory sales of goods produced on-site. The change in zoning will bring the operation of the existing uses into conformity with zoning and allow for future retail use. No new improvements are proposed, other than interior build-out to accommodate new tenants. Currently the buildings contain approximately 21,685 square feet of retail space, and approximately 18,998 square feet of office space. There are 37 parking spaces between the surface lot and the below-grade parking located in the 1980 N. Clybourn building.
