ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1 Neighborhood District symbols and indications as shown on Map No. 5-J in the area bounded by

the alley next north of and parallel to West
Armitage Avenue; North Kedzie Avenue; West Armitage Avenue;
and a line 35 feet west of and parallel to North Kedzie Avenue

to those of a C1-3 Neighborhood District.

SECTION 2. This ordinance takes effect after its passage and approval.

Narrative

Project: The applicant intends to use the subject property to allow the expansion of an existing accessory use outdoor patio that serves the existing tavern of the adjacent property located at 3204-06 W. Armitage. The existing outdoor patio is 1925 sq. ft and will add 1248 for a total of 3173 sq.ft. outdoors. The interior adjacent tavern is 4238 sq ft. The total combined outdoor patio space and interior tavern space will be 7411 sq.ft. There is no parking and no dwelling units at the subject property.

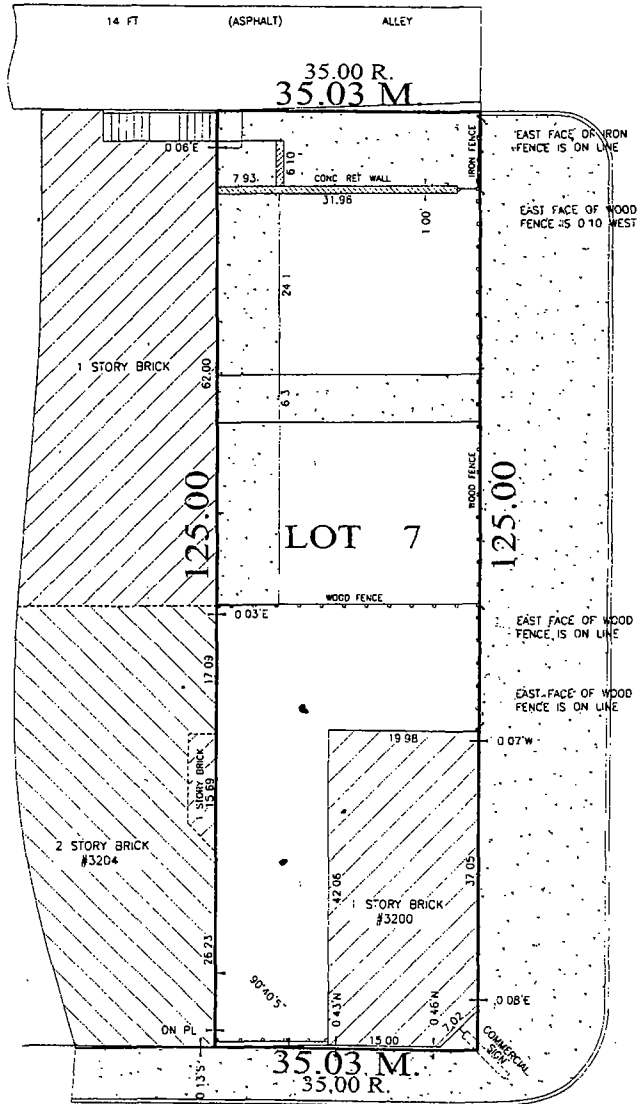

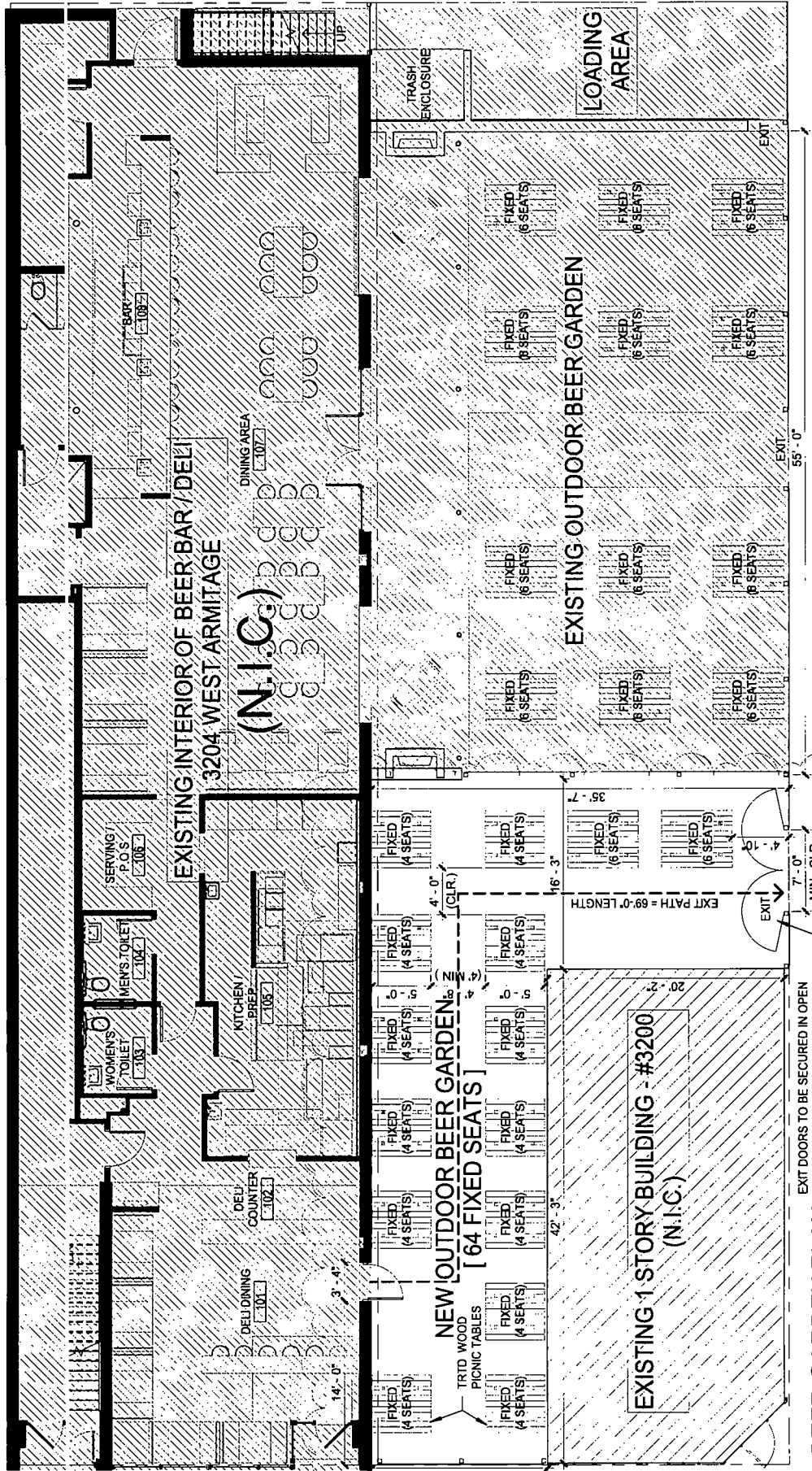



In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about August 22, 2019, I, the undersigned, will file an application for a change in zoning from a C1-1 Neighborhood Commercial District to a C1-3 Neighborhood Commercial District on behalf of ELSEWHERE LLC for property located at 3200 W. Armitage Avenue.

The applicant seeks a zoning amendment to allow an existing accessory use outdoor patio of 1925 square feet to expand to 3173 square feet adjacent to the existing tavern at 3204-06 W. Armitage Avenue, for a total of 7411 square feet combined indoor and outdoor at 3200 and 3204-06 W. Armitage.

An existing 1-story building of 841 square feet is currently vacant at 3200 W. Armitage and will remain so with no changes. The existing tavern at 3204-06 W.
