SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-1 Neighborhood District symbols and indications as shown on Map No. 5-J in the area bounded by

the alley next north of and parallel to West Armitage Avenue; North Kedzie Avenue; West Armitage Avenue; and a line 35 feet west of and parallel to North Kedzie Avenue

to those of a C1-3 Neighborhood District.

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about August 22, 2019, I, the undersigned, will file an application for a change in zoning from a C1-1 Neighborhood Commercial District to a C1-3 Neighborhood Commercial District on behalf of ELSEWHERE LLC for property located at 3200 W. Armitage Avenue.

The applicant seeks a zoning amendment to allow an existing accessory use outdoor patio of 1925 square feet to expand to 3173 square feet adjacent to the existing tavern at 3204-06 W.
