#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended changing all of the Planned Development Number 1218 symbols and indications as shown on Map No. 12-D in the area bound by

The alley next north of and parallel to East 53rd Street; a line extending south beginning at a point 53 feet west of South Kenwood Avenue and ending at a point 101.8 feet west of South Kenwood Avenue; East 53rd Street; and a line beginning at a point 422.72 feet west of South Kenwood Avenue extending north to the alley next north of and parallel to East 53rd Street,

to the designation of Planned Development Number 1218, as amended, subject to such use and bulk regulations as are set forth in the Planned Development attached hereto and to no others.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

# Enterprise Leasing Company of Chicago, LLC 1330 E. 53<sup>rd</sup> Street

#### **Project Narrative**

Enterprise Leasing Company of Chicago, LLC ("Enterprise"), has applied for a minor change to the PD to permit Enterprise's proposed indoor car rental use at the Property.

The Property consists of a 13-story mixed use residential and commercial structure known as Vue53 located on a gross site area of 64,354 sf, containing 267 apartment units, a Target and an Xfinity retail store, and an indoor three story parking garage. The parking garage has an ingress and egress and contains 230 parking spaces. In lieu of the parking spaces currently rented by Enterprise, Enterprise proposes to lease 30 indoor parking spaces, 1,200 sf of floor space for office area and service area (consisting of approximately 6000 square feet) within such parking garage for the purpose of operating an indoor car rental business. Approximately five of these parking spaces will be occupied by A modular (removable) rental office and/or utilized for parking by Enterprise's employees and 30 of these parking spaces would be used to park cars for rental to the general public.

#### Enterprise further proposes as follows:

- 1. Enterprise's business at the Property would consist of indoor rental of automobiles and/or noncommercial vehicles (minivans and/or sport utility vehicles) and incidental maintenance. Other than routine cleaning, Enterprise would not repair or restore vehicles at the Property. The proposed use would be a relocation of the car rental business currently operated by Enterprise at 5508 S. Lake Park Ave., Chicago.
- 2. Enterprise would operate its business and be open to the public at the Property during customary business hours (8 a.m. to 6 p.m. Monday through Friday and Saturday 9 a.m. 12 p.m.); customers may also return cars to designated spaces after normal business hours. Rental cars would be stored within Enterprise's premises overnight and on weekends.
- 3. Enterprise anticipates 3-5 transactions per business hour and accordingly its operation at the Property would not have a material impact on traffic.
- 4. Other than installing its removable modular rental office and customary identifying signage, Enterprise does not propose to make any material changes to the development or to alter the appearance thereof.
- 5. If the requested minor change is granted, the Property will remain in compliance with the parking standard set forth in the PD and with the parking standard set forth in Sec. 17-10-0207-N of the Code. In this regard we note that the Bulk Regulations Table set forth in the

PD provides for a minimum of 200 parking spaces at the Property, and that such minimum will continue to be met. We note further that under Sec. 17-10-207 of the Code, a 267-unit property located in a B-5 district would also require a minimum of 1 space for the first 100 units and .60 spaces for additional units, or 200 parking spaces.

Under paragraph 5 of the PD, the following uses are permitted at the Property: residential dwelling units, ground floor residential dwelling units, retail sales, financial services, accessory parking including two parking spaces reserved for car sharing purposes, and accessory uses. Although indoor Light Equipment Sales/Rentals are not specifically permitted within the PD, such use is permitted by right within the B3-5 Community Shopping District, which is the underlying zoning designation for the Property.

Car rental uses are consistent and not incompatible with other uses within the Property, including residential parking and general retail. The proposed use by Enterprise is a needed benefit and convenience for the community, which is heavily occupied by college students and other individuals who do not own cars.

The proposed use by Enterprise will not result in an adverse impact on the PD or surrounding neighborhood, will not result in an increase in the bulk or density or otherwise change the character of the development, and would therefore constitute a minor change.

In further support of this request we attach (a) a rendering showing the proposed location of Enterprise's business premises within the Property; (b) photos showing examples of Enterprise's comparable locations within Chicago parking garages and (c) renderings depicting the exterior and N/S/E/W elevations of the Property.

Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the plans.

Ingress or egress shall be pursuant to the plans and may be subject to the review and approval of the Departments of Housing and Economic Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II Approval, the submitted plans must be approved by the Department of Transportation.

- 4. This Plan of Development consists of sixteen statements; a Bulk Regulations Table; an Aerial Site Map; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; Site Plan; a Green Roof Plan/Landscape Plan; a Ground Floor Plan; Floor Plans for Levels 2 and 3; and Building Elevations prepared by Valerio Dewalt Train Associates dated May 16, 2013. The building will have a green roof of approximately 16,700 square feet. All buildings constructed in this Planned Development shall conform to the City of Chicago Sustainable Development Policy Matrix in effect on the date of approval of this Planned Development.

The applicant acknowledges and agrees that the rezoning of the Property from B1-2 and 83-2 to 83-5 for construction of this Planned Development triggers the requirements of Section 2-45-110 of the Municipal Code (the "Affordable Housing Ordinance"). Any developer of a "residential housing project" within the meaning of the Affordable Housing Ordinance ("Residential Project") must: (i) develop affordable housing units as part of the Residential Project; (ii) pay a fee in lieu of the development of affordable housing units; or (iii) any

combination of (i) and (ii). In accordance with these requirements and the Affordable Housing Profile Form attached hereto as an exhibit, the Applicant has agreed to provide 27 affordable housing units in the Residential Project for households earning up to 60 percent of the Chicago Primary Metropolitan Statistical Area median income (the "Affordable Units"), or make a cash payment to the Affordable Housing Opportunity Fund in the amount of \$100,000 per unit ("Cash Payment"). The Commissioner of HED may enforce remedies for breach of the Affordable Housing Agreement, and enter into settlement agreements with respect to any such breach, subject to the approval of the Corporation Counsel, without amending the Planned Development.



You are receiving this letter because you own property within 250 feet of 1330 East 53<sup>rd</sup> Street ("Property"), and this letter is part of the legal notice requirements of the Chicago Zoning Ordinance Section 17-13-0107.
