BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-3 Community Shopping District

symbols and indications as shown on Map No.11-G in the area bounded by

West Lawrence Avenue; North Kenmore Avenue; a line 100.1 feet south of and parallel to West Lawrence Avenue; and the alley next west of and parallel to North Kenmore Avenue,

to those of a B3-5 Community Shopping District and a corresponding use district is

hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
