BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 4-G in the area bounded by:

a line 73.00 feet north of and parallel to West 18th Street; the public alley next east of and parallel to South Throop Street; a line 49.00 feet north of and parallel to West 18th Street; and South Throop Street

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 11, 2019, the undersigned will file an application for a change in zoning from a C1-2 Neighborhood Commercial District to a B2-3 Neighborhood Mixed-Use District on behalf of Veronica Chavez (the "Applicant") for the property located at 1653 South Throop Street, Chicago, Illinois. The property is bounded by:

a line 73.00 feet north of and parallel to West 18th Street; the public alley next east of and parallel to South Throop Street; a line 49.00 feet north of and parallel to West 18th Street; and South Throop Street.

The subject property is improved with a two-story building containing two residential dwelling units, a commercial unit and three parking spaces.
