#### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the Residential-Business Planned Development No. 301 District symbols and indications as shown on Map No. 3-F in the area bounded by

West Schiller Street; North Wells Street, West Evergreen Avenue and North Park Avenue

to the designation of Residential-Business Planned Development No. 301, as Amended which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development attached and made a part thereto and to no others.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.

## RESIDENTIAL-BUSINESS PLANNED DEVELOPMENT NO. 301, AS AMENDED PLAN OF DEVELOPMENT STATEMENTS

- 1. The area delineated herein as Residential-Business Planned Development No. 301, as amended ("Planned Development"), is generally located at 213 West Schiller Street, Chicago, Illinois and consists of approximately 137,969 square feet of net site area (the "Subject Property"), as shown and as is depicted on the attached Planned Development Boundary and Property Line Map. The Applicant The Catherine Cook School, an Illinois Not-For-Profit Corporation, has filed this application on its own behalf and with the consent of the Property Owner Cobblesquare Place Associates, an Illinois Limited Partnership.
- 2. The requirements, obligations and conditions contained within this Planned Development, as amended, shall be binding upon the Applicant and Property Owner, their successors and assigns and, if different than the Applicant and/or Property Owner's successors and assigns and, if different than the Applicant and/or Property Owner, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Subject Property, at the time of application for amendments, modifications or changes (administrative, legislative, or otherwise) to this Planned Development are made, shall be under single ownership or designated control. [Single designated control is defined in Section 17-8-0400 of the Chicago Zoning Ordinance.]
- 3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees. Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Planned Development.

Ingress or egress shall be pursuant to the Planned Development and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

4. This Plan of Development, as amended, consists of fifteen (15) Statements: a Bulk Regulations and Data Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; a Site Plan; Floor Plans (for 1338 North Wells Street and 211 West Schiller Street); and Building Elevations, all of which were prepared by Filoramo Talsma Architects and which are submitted and referenced herein - accordingly.

Applicant: The Catherine Cook School Address: 213 West Schiller Street Introduced: September 18, 2019

In any instance where a provision of this Planned Development, as amended, conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the tenets of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

- 5. The following uses are allowed in the area delineated herein as Residential-Business Planned Development No. 301, as amended, and shall include the following: dwelling units; accessory health and swimming pool facilities, accessory off-street parking and loading, business, commercial, retail, personal service, school (classrooms, offices, studios), incidental and accessory uses, and other uses permitted in a B3 Community Shopping District (except that otherwise applicable restrictions marked by an asterisk in the current Zoning Ordinance shall not apply).
- 6. On-premise signs and temporary signs, such as business identification, construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development (DPD). Off-premise signs are prohibited within the boundary of the Planned Development.
- 7. For purposes of height calculations and measurements, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations established by the Federal Aviation Administration (FAA).
- 8. The maximum permitted floor area ratio (FAR), for the Property, shall be in accordance with the attached Bulk Regulations and Data Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The maximum permitted floor area ratio (FAR) identified in the Bulk Regulations Table has been determined using a Net Site Area of 137,969 square feet and a base FAR of 2.5.
- 9. Upon review and determination, and pursuant to section 17-13-0610 of the Zoning Ordinance, Part II Review shall be assessed a fee, by the Department of Planning and Development (DPD). The fee, as determined by Staff at the time of submission, is final and binding on the Applicant and must be paid to the Chicago Department of Revenue, prior to the issuance of any Part II Approval.
- 10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any corresponding regulations and guidelines, including Section 17-13-0880 of the Zoning Ordinance. Final landscape plan review and approval will be by the Department of Planning and Development (DPD). Any interim reviews associated with Site plan review or Part II Reviews, are conditional until final Part II Approval.

- 11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Section 13-32-085, or any other provision of the Municipal Code of Chicago.
- 12. The terms and conditions of development, under this Planned Development Ordinance, may be modified administratively, pursuant to Section 17-13-0611-A of the Zoning Ordinance, by the Zoning Administrator, upon written application for such modification, by the Applicant and/or Property Owner, its successors and assigns and, if different than the Applicant and/or Property Owner, the legal titleholders and any ground lessors.
- 13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Subject Property. Plans for all buildings and improvements, within the Planned Development Boundary, shall be reviewed and approved by the Mayor's Office for People with Disabilities (MOPD), to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
- 14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. The Applicant shall obtain the number of points necessary to meet the requirements of the Chicago Sustainable Development Policy, in effect at the time the Part II review process is initiated for each improvement that is subject to the aforementioned Policy and must provide documentation verifying compliance.
- 15. This Planned Development shall be governed by Section 17-13-0612. Should this Planned Development ordinance lapse, the Commissioner of the Department of Planning and Development shall initiate a Zoning Map Amendment to rezone the property to a B3-3 Community Shopping District.





Existing Land-Use Map




