
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District symbols as shown on Map No. 9-N in the area bounded by:

A line 160.72 feet north of and parallel to West Roscoe Street; the public alley next east of and parallel to North Harlem Avenue; a line 110.72 feet north of and parallel to West Roscoe Street; North Harlem Avenue.

To those of a B3-2, Community Shopping District

SECTION 2. This Ordinance takes effect after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 10, 2019, the undersigned will file an Application for a change in zoning from a B3-1 Community shopping District to a B3-2 Community Shopping District on behalf of the Applicant, Christopher Roszkowski, for the property located at 3413-15 North Harlem Avenue, Chicago, Illinois.

The subject property is currently improved with a two-story mixed-use building with commercial units on the ground floor and 2 dwelling units on the second floor. The Applicant intends to build a third story addition to the existing building and establish 2 dwelling units within that third floor addition, for a total of 4 dwelling units at the subject property. The Applicant needs a zoning change in order to comply with the minimum lot area per dwelling unit requirements of the Zoning Ordinance.


