ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District symbols as shown on Map No. 9-N in the area bounded by:

A line 160.72 feet north of and parallel to West Roscoe Street; the public alley next east of and parallel to North Harlem Avenue; a line 110.72 feet north of and parallel to West Roscoe Street; North Harlem Avenue.

To those of a B3-2, Community Shopping District

SECTION 2. This Ordinance takes effect after its passage and due publication.
