ORDINANCE BRYN MAWR SHERIDAN Acct. No. 274023 - 1 Permit No. 1142007

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BRYN MAWR SHERIDAN, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Roof Eave(s) projecting over the public right-of-way adjacent to its premises known as 5556 N. Sheridan Rd..

Said Roof Eave(s) at W Bryn Mawr measure(s):

One (1) at nineteen (19) feet in length, and one point three three (1.33) foot in width for a total of twenty-five point two seven (25.27) square feet. Existing roof eave is approximately sixty-six (66) feet above grade level.

One (1) at thirty-nine point two five (39.25) feet in length, and one point three three (1.33) foot in width for a total of fifty-two point two (52.2) square feet. Existing roof eave is approximately sixty-six (66) feet above grade level.

One (1) at eighteen point four one (18.41) feet in length, and one point zero eight (1.08) foot in width for a total of nineteen point eight eight (19.88) square feet. Existing roof eave is approximately sixty-six (66) feet above grade level.

Said Roof Eave(s) at N. Sheridan Rd measure(s):

One (1) at twelve point seven five (12.75) feet in length, and one point five (1.5) foot in width for a total of nineteen point one three (19.13) square feet. Existing roof eave is approximately sixty-six (66) feet above grade level.

One (1) at eighteen (18) feet in length, and one (1) foot in width for a total of eighteen (18) square feet. Existing roof eave is approximately sixty-six (66) feet above grade level.

One (1) at thirty-nine point two five (39.25) feet in length, and one (1) foot in width for a total of thirty-nine point two five (39.25) square feet. Existing roof eave is approximately sixty-six (66) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1142007 herein granted the sum of two thousand four hundred (\$2,400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


