SUBSTITUTE SUBDIVISION ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. The Commissioner of the Chicago Department of Transportation, whether acting or actual, or his designee, is hereby authorized and directed to approve the Pullman Park – Phase 6 Subdivision, a proposed resubdivision of certain lots owned by Pullman QOZB LLC, a Delaware limited liability company ("Developer"), in the block bounded generally by E. 106th Place, E. 107th Street, S. Doty Avenue / S. Woodlawn Avenue and railroad tracks to the west, and legally described in the attached plat (Exhibit A, CDOT File: 14-09-19-3894) which, for greater certainty, is hereby made a part of this ordinance.

SECTION 2. The resubdivision herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois, a copy of this ordinance, together with the full-sized corresponding plat as approved by the Department of Transportation's Acting Superintendent of Maps and Plats.




