ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 9-L in the area bounded by

West Roscoe Street; A line 30 feet east of and parallel to North Lockwood Avenue; the public alley next south of and parallel to West Roscoe Street; and North Lockwood Avenue

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The undersigned, William J.P. Banks, being first duly sworn on oath, deposes and states the following:


