BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as show n on Map No. 9 - H in the area bounded by:

A line 291 feet north of and parallel to West Cornelia Avenue; North Ashland Avenue; A line 266 feet north of and parallel to West Cornelia Avenue; and the alley next west and parallel to North Ashland Avenue.

to those of a C1-2 Neighborhood Commercial District.




