BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The Comptroller is directed to install parking meters on West Fullerton Avenue on:

- The north side of the street from North Greenview Avenue to North Southport Avenue
- The south side of the street from North Bosworth Avenue to North Southport Avenue.

SECTION 2. Section 9-64-206 of the Municipal Code of Chicago is hereby amended by adding the language underscored as follows:

9-64-206 Parking meters – Hours of operation.

Notwithstanding any prior ordinance establishing different hours of operation, the hours of operation for a parking meter, except as provided by subsections (g), (h), and (i) shall be as follows:

West North Avenue, from Ashland Avenue to Winchester Avenue.


