#### **ORDINANCE**


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single-Unit (Detached House) symbols and indications as shown on Map No. 13-I in an area bound by

A line 268.37 feet south of and parallel to West Argyle Street; the public alley next east of and parallel to North Troy Street; a line 298.37 feet south of and parallel to West Argyle Street; And North Troy Street

to those of a RT-4, Residential Two-Flat, Townhouse and Multi-Unit Districts. SECTION 2. This ordinance takes effect after its passage and due publication.
