ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the current B3-2 Community Shopping District symbols and indications as shown on Map Number 9-G in the area bounded by:

A line 141.15 feet north of and parallel to West Addison Street; North Southport Avenue; a line 91.15 feet north of and parallel to West Addison Street; and the alley next west of and parallel to North Southport Avenue,

To those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about November 6, 2019 the undersigned will file an application for a change in zoning from a B3-2 Community Shopping district to a C1-2 Neighborhood Commercial District for the property located at 3608-3610 North Southport Avenue.

The applicant seeks an amendment to the zoning ordinance to allow for the continued operation of an existing dog/animal day care. The property is improved with one approximately 3,789 square foot, 35 foot tall 2 and 3 story building and will be used for an animal day care shelter/kennel with boarding, and one approximately 50 square foot, 15 foot tall, 1-story restaurant building. No changes to the existing buildings are planned. There are two parking spaces on site.
