SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the RS3 Residential Single-Unit (Detached House)

District symbols and indications as shown on Map No 8-G in the area bounded by

West 33<sup>rd</sup> Street; the alley next east of and parallel to South Morgan Street; a line 29.20 feet south of and parallel to West 33<sup>rd</sup> Street; and South Morgan Street,

to those of a C1-3 Neighborhood Commercial District and a corresponding use district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
