ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the current B3-2 Community Shopping District symbols and indications as shown on Map Number 9-G in the area bounded by:

A line 55.0 feet northwest of and parallel to West Cornelia Avenue; North Clark Street; West Cornelia Avenue; and the alley next southwest of and parallel to North Clark Street.

To those of a B3-3 Community Shopping District.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and due publication.

PROJECT NARRATIVE AND PLANS FOR TYPE-1 ZONING MAP AMENDMENT AT
3500-3502 NORTH CLARK STREET

The Applicant requests a zoning change for the property located at 3500-3502 North Clark Street from the B3-2 Community Shopping District to the B3-3 Community Shopping District in order to construct a four (4) story, forty-six (46) foot, nine (9) inch tall transit-oriented, residential building with 4,455 square feet of commercial space on the ground floor. The proposed building will have eighteen (18) dwelling units located on the second through the fourth floors, five (5) parking spaces located on the ground floor and eighteen (18) bicycle parking spaces located on the upper floors. The proposed building is approximately 770 feet from the nearest CTA station and, accordingly, is a Transit Served Location eligible for a reduction of the minimum lot area from 400 square feet per unit to a minimum of 300 square feet per unit, and a parking reduction by up to fifty (50) percent from the required eighteen (18) parking spaces. The Applicant proposes a further of greater than fifty (50) percent by way of this Type-1 rezoning application.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about November 6, 2019 the undersigned will file an application for a change in zoning from a B3-2 Community Shopping district to a B3-3 Community Shopping District for the property located at 3500-3502 North Clark Street.

The applicant seeks an amendment to the zoning ordinance in order to construct a 46.75 foot tall, 4-story, mixed-use building with 18 dwelling units, 4,455 square feet of commercial space, 5 automobile parking spaces and 18 bicycle parking spaces.
