#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

**SECTION 1.** Chapter 8-4 of the Municipal Code of Chicago is hereby amended by inserting new Section 8-4-305 as follows:

#### 8-4-305 Unlawful representation as transportation network driver.

(a) It shall be unlawful for any person to impersonate a transportation network driver or to falsely represent themselves as a transportation network driver with the intent to defraud or deceive any other person. For the purposes of this Section, "transportation network driver" has the same definition as set forth in Section 9-115-010 of this Code.

(b) It shall be unlawful for any person to falsely represent themselves as a transportation network driver with the intent to defraud or deceive any other person by displaying or using one or more of the following: (1) any signage or emblems issued under Section 9-115-120 of this Code; (2) any counterfeit or imitation of signage or emblems issued under Section 9-115-120 of this Code; (3) an identification card issued under Section 9-115-170 of this Code; (4) a counterfeit or imitation identification card issued under Section 9-115-170 of this Code; (5) a revoked or expired transportation network chauffeur license issued under Section 9-115-150 of this Code; or (6) a counterfeit or imitation of transportation network chauffeur licenses issued under Section 9-115-150 of this Code; or (6) a counterfeit or imitation of transportation network chauffeur licenses issued under Section 9-115-150 of this Code; or (6) a counterfeit or imitation of transportation network chauffeur licenses issued under Section 9-115-150 of this Code; or (6) a counterfeit or imitation of transportation network chauffeur licenses issued under Section 9-115-150 of this Code. (c) Any person who violates this Section shall be subject to a fine of not less than \$10,000 nor more than \$20,000, or imprisonment for a period not to exceed 180 days, or both, for each offense. Each violation shall constitute a separate and distinct offense.

**SECTION 2.** The provisions of this ordinance are declared to be separate and severable. The invalidity of any provision of this ordinance, or the invalidity of the application thereof to any person or circumstance, shall not affect the validity of the remainder of this ordinance, or the validity of its application to other persons or circumstances.

SECTION 3. This ordinance shall be in full force and effect 30 days after passage
