#20273 INTRO DATE DEC 18, 2019

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 9-G in the area bounded by

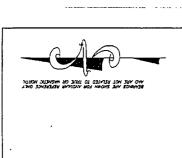
A line 175 feet north of and parallel to West School Street; the alley next east of and parallel to North Seminary Avenue; a line 150 feet north of and parallel to West School Street; and North Seminary Avenue

to those of a RM-5 Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance, please be advised that on or about December 18, 2019, the undersigned, will file an application for a change in zoning for the property located at 3317 North Seminary Avenue from a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to a RM-5 Residential Multi-Unit District

The owner of the property and the applicant of the Zoning Amendment is Semco Bass, LLC located at 1319 Edgewood Lane, Northbrook, IL 60062.

The purpose of the rezoning is to legalize the non-conforming existing ground floor dwelling unit in the existing 3 dwelling unit front building. After rezoning, there will be a total of 4 dwelling units in the front building. The height and exterior of the front building will remain unchanged. The existing 2 story, 1 dwelling unit building in the rear will remain unchanged. There is no existing parking, and non is required. There will be no commercial space.
