Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Kilwins Ice Cream and Chocolate, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 3519 N. Clark St..

Said Awning(s) at N. CLARK STREET measure(s):

One (1) at twenty-nine point one (29.1) feet in length, and two point nine five (2.95) feet in width for a total of eighty-five point eight five (85.85) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1143035 herein granted the sum of fifty-four dollars and ten cents (\$54.10) per annum in advance.


A 25% penalty will be added for payments received after due date.


