#### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-3 Neighborhood Commercial District symbols and indications as shown on Map Number 11-G in the area bounded by:

a line 152.5 feet southeast of and parallel to West Belle Plaine Avenue; a line 250.0 feet northeast of and parallel to North Broadway; a line 202.5 feet southeast of and parallel to West Belle Plaine Avenue; and North Broadway

to those of a B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about January 8, 2020, the undersigned will file an application for a change in zoning from C1-3 Neighborhood Commercial District to B2-3 Neighborhood Mixed-Use District on behalf of the applicant, David Lee Hinkamp, for the property located at 4071 N. Broadway. The applicant is also the owner of the subject property.

The purpose of the proposed change in zoning is to allow for the development of 1,273.8 square feet of office space within the existing building envelope.
