ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 15-J in the area bounded by:

the public alley next north of and parallel to West Bryn Mawr Avenue; a line 158.00 feet east of and parallel to North Spaulding Avenue; West Bryn Mawr Avenue; and a line 58.00 feet east of and parallel to North Spaulding Avenue

to those of a B2-3 Neighborhood Mixed-Use District.


SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about January 8, 2020, the undersigned will file an application for a change in zoning from a B1-2 Neighborhood Shopping District to a B2-3 Neighborhood Mixed-Use District on behalf of 3244 – 50 Bryn Mawr LLC (the "Applicant") for the property located at 3244-52 West Bryn Mawr Avenue, Chicago, Illinois 60659. The property is bounded by:

the public alley next north of and parallel to West Bryn Mawr Avenue; a line 158.00 feet east of and parallel to North Spaulding Avenue; West Bryn Mawr Avenue; and a line 58.00 feet east of and parallel to North Spaulding Avenue.

The subject property measures 12,500 square feet and is improved with a one-story vacant commercial building that measures approximately 7,528 square feet. The Applicant proposes to demolish all but the façade of the existing building (the façade is approximately 5 feet deep) and will construct a four-story mixed-use building that will incorporate the existing building's façade. The new building will contain approximately 1,500 square feet of ground floor commercial space, thirty parking spaces on the ground floor, and thirty residential dwelling units on the upper floors. The height of the building will be 53 feet and 2 inches.
