#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1, Neighborhood Shopping District symbols and indications as shown on Map No. 24-H in an area bound by

A line 138.82 feet north of and parallel to West 99<sup>th</sup> Street; a line 213.26 feet east of and parallel to South Longwood Drive; West 99<sup>th</sup> Street; And the public alley next east of and parallel to South Longwood Drive

to those of a C2-2, Motor Vehicle-Related Commercial District. SECTION 2. This ordinance takes effect after its passage and due publication.
