BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 8-32-130 of the Municipal Code of Chicago is amended by deleting the language stricken through and inserting the language underscored, as follows:

8-32-130. Loading and unloading operations.

- (a) No person shall undertake or cause the loading, unloading, opening, closing or other handling of boxes, crates, containers, building materials, garbage cans, recycling cans, dumpsters or similar objects waste or recycling containers between the hours of 10:00 PM and 7:00 AM in such a manner as to cause a noise disturbance within a residential district 250 feet of any residential building or hospital, or within a noise sensitive zone as defined by 8-32-060 of the municipal code.
- (b) Any person who violates this section shall be liable for a penalty of not less than \$250, nor more than \$500 for the first violation; not less than \$500 nor more than \$750 for the second violation within one calendar year; and \$1,000 for the third and each subsequent violation within one calendar year. Each day a violation continues shall constitute a separate and distinct offense.
- (c) This section shall be enforced by the departments of streets and sanitation, finance and police.

(Omitted text is unaffected by this ordinance)

SECTION 2. This ordinance shall be effective upon passage and publication.
