ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1, Neighborhood Shopping District symbols and indications as shown on Map No. 5-K in the area bounded by

West Fullerton Avenue; a line 75 feet west of and parallel to North Lowell Avenue; the Alley next South of and parallel to West Fullerton Avenue; and a line 125 feet West of and parallel to North Lowell Avenue.

to those of a C2-1, Motor Vehicle-Related Commercial District.

Section 2. This ordinance takes effect after its passage and approval.


