BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4, Residential Two-Flat. Townhouse and Multi-Unit District symbols and indications as shown on Map No.4-F in the area bounded by

South Ruble Street; the alley next north of and parallel to west 18th Street; a line 150 feet east and parallel to south Ruble Street; and west 18th Street.

to those of a C2-2, Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
