ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (detached house) District symbols and indications as shown on Map No. 7-G in the area bounded by

A line 247.32 feet north of and parallel to West Barry Avenue; the pubic alley next east of and parallel to North Kenmore Avenue; a line 222.3 feet north of and parallel to West Barry Avenue; and North Kenmore Avenue.

to those of a RT 3.5 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


